## Q & A – TAX14003

1. Q. The proposal mentions two different locations. Are these in the same building or would they be connected via WAN? We can only cluster if our appliances are on the same LAN segment.

A. Different Building connected WAN.

2. Q. Will you ever need to scale beyond 100 users? Our MAG2600 scales up to exactly 100, but if you envision growth we would recommend the next platform up.

A. There could be a possible in the future to scale about 100.

3. Q. Is this replacing an existing SA solution?

A. No – New completely all around.

4. Q. You mention support, but not time frames for response. Since you have two units, you can probably get away with less support. We have next day or core plus (return to factory). We are going with next day replacements for now; if that is not good, please let me know.

A. 8 to 5 next business day will be fine.
