Vehicle season has started for the West Virginia State Agency for Surplus Property, said WVSASP Vehicle Coordinator Doug Elkins. He encourages eligible organizations to check out the large variety of vehicles in stock for purchase.

Spring often means an influx of new vehicles to the West Virginia State Agency for Surplus Property (WVSASP) as agencies retire their fleet vehicles. This opens up an opportunity for eligible organizations looking for a good used vehicle to meet its needs.

“Replacement schedules for state agencies and vehicle production schedules affect the number of vehicles being retired, but spring is traditionally a very busy season for WVSASP, and now would be an excellent time to visit the Dunbar lot and see what exactly we have in stock,” said Vehicle Coordinator Doug Elkins. “We have a large variety of vehicles in stock, from cars and SUVs to passenger vans and even specialty vehicles.”

Elkins said that retired state vehicles present a good value for the eligible organization dollar since they are maintained to state fleet standards. “Our vehicles are very reasonably priced for the year and model in question,” he said. Agencies that are looking to retire vehicles should keep apprised of requirements when bringing vehicles to the West Virginia State Agency for Surplus Property (WVSASP).

“Agencies need to set up an F-Doc in the West Virginia Financial Information Management System (WVFIMS) or fill out a Surplus Property Retirement Form (WV-103),” said Vehicle Coordinator Doug Elkins. “At WVSASP, Sher-

Our offices will be open from 8:30 a.m. to 7 p.m. on May 5, June 2, July 7 and August 4 for the convenience of our existing and new customers.

able. WVSASP's normal business hours are from 8:30 a.m. to 4:30 p.m. Monday through Friday.

WVSASP Marks Milestone with Online Auction Sales

The West Virginia State Agency for Surplus Property (WVSASP) continues to find success through the world of online auctions, having recently crossed the threshold of 1,000 items sold through the online auction website, GovDeals.

Administrative Services Manager Jordan Kirk said online auctions through the site have generated more than \$1.3 million in income. "Using online auctions works for Surplus as a method of disposing of items which may otherwise be difficult to sell through traditional means," he said.

Online auctions are often used to dispose of property which would be logistically difficult to transport to WVSASP's Dunbar warehouse. "We have had success selling large items, such as farm equipment, or vehicles that have been on the lot for a long period of time," Kirk said. The result has been fewer absolute auctions for the agency, as online sales have steadily increased, he said.

Kirk said buyers are responsible

for the shipping of items or having the manpower and equipment to remove an item from the location. "Buyers who purchase from WVSASP through an online auction know what they are bidding on and what they need to do to get the item," he said.

E-Cycling Event Scheduled for June 4

The U.S. General Services Administration, the West Virginia State Agency for Surplus Property, and Federal Prison Industries (UNICOR) will be conducting an electronics recycling event on Wednesday, June 4. The event will run from 9 a.m. to 3 p.m. and is open to all federal, state and local government agencies. During the day of the event, agencies will be welcome to drop off eligible eScrap items for recycling by UNICOR at no cost to the agency. The collection point is the West Virginia State Agency for Surplus Property located at 2700 Charles Avenue, Dunbar.

Jim Farmer Has Seen Plenty in 35 Years of Service with West Virginia State Agency for Surplus Property



Jim Farmer has marked 35 years with the West Virginia State Agency for Surplus Property. He said the agency has changed substantially, including the addition of new offices and paving throughout the grounds.

With all the changes he has seen at the West Virginia State Agency for Surplus Property (WVSASP), Jim Farmer could possibly qualify as the agency's historian.

Farmer began working at WVSASP in 1979 as the janitor and night watchman. Today, he is a Storekeeper I and he frequently says, "I can remember when" upon recalling the many changes that have occurred at WVSASP and the many co-workers he has worked with during the last 35 years.

"This place has improved a whole lot since I have been here. When I first started, the parking lot was gravel and when it rained, it was nothing but mud out there. Our office building wasn't here. We were in the [noticeably smaller] auction building," Farmer said, noting he was a night watchman in part because the perimeter fencing at the Dunbar property was minimal.

Now, Farmer does not have to worry about mud puddles as the lot is paved and security cameras and upgraded fencing dot the property. He, like all the WVSASP employees, wears many hats.

His primary duties of the past seven years have been assisting with the numerous new and used state-owned and leased vehicles that must first be inspected at WVSASP. Farmer also assists with the auctions and occasionally accompanies staff when vehicles have to be brought to

WVSASP lot.

"There is a checklist of items we go over when vehicles come here. For the new vehicles, we are making sure things like there are no dents or dings on them. I help get them ready to go out of here. For the vehicles sent

When retiring a vehicle, agencies should make sure that the vehicle is clean and has been inspected for possible body damage, said Vehicle Coordinator Doug Elkins.

ry Fewell handles WVFIMS and retirement forms, and the retirement must be approved by WVSASP.”

Elkins said an agency should notify WVSASP when it wishes to retire property so a date and time can be set to bring the vehicle in. Vehicle retirement typically has two scenarios: an agency may simply retire the vehicle or the vehicle may be brought in for replacement with a new vehicle.

When retiring a vehicle, an agency should be mindful of its condition when bringing it into WVSASP. “We recommend that the vehicle be cleaned before being brought to WVSASP and all trash and personal items removed,” Elkins said. Also, the vehicle should have all hubcaps, no cracks in the windshields and at least one-eighth of a tank of gas.

He added that any major body damage should be repaired. “Small dents and scratches are OK, but anything in excess deters from selling the vehicle for a better price,” he said.

By adhering to these rules, Elkins said vehicle retirement and replacement can be a quicker and smoother process. “We want to make the process as efficient as possible for agencies,” he said.



Go to intersection with Charles Avenue -- if you miss 16th Street, go to 22nd Street which is also a throughway. Turn right onto Charles Avenue, continue to 28th Street and turn right. The West Virginia State Agency for Surplus Property is on that corner inside the cyclone fence.

here by other state agencies, we check things like the engine, transmission, windshield wipers and things like that to make sure everything is working before we put them up for sale," Farmer said. "I see a lot of vehicles all year long. Starting in April and going until the end of October, we are super busy with all the cars that come through here."

Farmer was born and raised just outside of Beckley and moved to Charleston to find work outside of the coal mines. He said working at WVSASP has been a worthy career though weather occasionally puts a damper on his predominately outside duties.

"It has been good here but when it gets real cold, rains or snows, it is not so much fun," he said. "Once, back when I was the night watchman, we got a huge snowstorm that started about midnight and the governor declared a state of emergency and the buses didn't run the next day. I had to walk home. It was probably about 10 miles. I hope to never have to do that again."

Terms: All organizations must pay by check or credit card — no cash transactions permitted.

Terms and Conditions of Sale

FEDERAL AND STATE REGULATIONS: Acceptance of Federal equipment and supplies by users who have established eligibility to participate in the WVSASP is subject to certifications and agreements identified on the reverse side of the Distribution Document. **1:** Federal equipment and supplies are restricted to institutional use only, not personal use, and are to be used for a minimum of one year; **2:** All vehicles and items with an acquisition cost of \$5,000.00 or more shall be used for the purpose(s) for which acquired within one year from the date the property was invoiced and used for 18 months thereafter. **3:** During the restriction period, the property shall not be sold, traded, leased, lent, bailed, cannibalized, encumbered or otherwise disposed of or removed from the State of West Virginia without the express approval of the WVSASP. The recipients of Federal property are urged to contact the WVSASP prior to taking any actions which might be interpreted as modifying any of the certifications and agreements stated on the reverse side of the Distribution Document.

TERMS: Payment required upon receipt unless previous arrangements have been made. Payment must be by check or credit card issued against an eligible organization. No personal checks, money orders or cash transactions are permitted.

SHIPPING: All service charges are FOB Dunbar Warehouse unless expressly indicated. Out-shipping can be arranged by calling (304) 766-2626. Delivery charges will be added to the invoice.
