**DELTA AIR LINES, INC. ("Delta" or "DL"),** a Delaware corporation having its registered office at 1030 Delta Boulevard, Hartsfield Jackson International Airport, Atlanta, Georgia 30320 U.S.A.:

KONINKLIJKE LUCHTVAART MAATSCHAPPIJ N.V. ("KLM Royal Dutch Airlines" or "KL"), a public limited liability company incorporated under the laws of the Netherlands and registered under the number 33014286 and having its registered office at Amsterdamseweg 55, Amstelveen, The Netherlands;

VIRGIN ATLANTIC AIRWAYS LIMITED ("Virgin Atlantic" or "VS"), a company registered in England with registered number 1600117, whose registered office is at The Office Manor Royal, Crawley, West Sussex, RH10 9NU, England;

and

#### **PREAMBLE**

WHEREAS, Air France, Alitalia, Delta, KLM and the Company entered into that certain Corporate Agreement dated effective as of March 12, 2014 (as amended from time to time, the "Agreement");

WHEREAS, the Agreement sets out the terms and conditions under which the Carriers established a corporate discount program with Company to provide Company with a discount on the purchase of tickets offered for sale by the Carriers;

WHEREAS, the Carriers and Company desire to amend the Agreement to add Virgin Atlantic as a Party to the Agreement on the terms set forth in this Amendment;

NOW, THEREFORE, in consideration of the covenants contained herein the parties hereto, intending to be legally bound hereby, agree to amend the Agreement as follows:

#### Article 1 - Amendment

The Parties hereby amend the Agreement as follows:

- Effective as of the Effective Date, Virgin Atlantic is added as a Party to the Agreement and is included as a "Carrier" within the scope of the Agreement.
- 2. The discount terms of Virgin Atlantic to be added to the corporate incentive program made available to the Company under the Agreement will be effective within fourteen (14) business days following Delta's receipt of an executed Amendment from Company. Such discount terms will be set forth on a new <a href="Exhibit A">Exhibit A</a> to the Agreement which shall (a) be delivered to the Company within thirty (30) days after the appropriate fare filing is complete and (b) replace in its entirety the existing Exhibit A to the Agreement as of such date.

## Article 2 - Miscellaneous

Capitalized terms used herein but not defined herein shall have the respective meanings set forth in the Agreement.

- 2. This Amendment, together with the Agreement, constitutes the entire agreement between the Parties with respect to the subject matter hereof.
- 3. All terms and conditions of the Agreement, including any Exhibits thereto, not modified herein will remain in full force and effect.
- 4. This Amendment may be executed in any number of counterparts and by the Parties on separate counterparts, each of which counterparts when executed and delivered shall be an original, but all of which shall together constitute one and the same instrument.
