Dear Mr. McAllister:

Verizon requests an administrative change order to clarify rate element descriptions for linking the invoice terminology to the contract terminology, and to add service option language. There is no increase in pricing associated with these rate elements. These changes will provide for increased accuracy and efficiency in the State's auditing of invoices for services ordered from the contract. A onetime adjustment will be made to reflect the below components that will now be zero rated, to also include the local loop and EF real time, back to the installation date.

In support of this change request, Verizon provides the following:

• Local Loop, billing description on price sheet, refers to a portion of a transport data circuit. All circuits offered in the contract contain a local loop component. The term 'Type 3 and Type 4 should be added to the pricing sheet for each type of data circuit offered (Private Line, Switched Ethernet, Frame Relay, ATM and MPLS).

• Management -refers to the Monitor/Notify management of the circuits and should be added

to the pricing sheet and billed at a zero rate.

EF Real Time, QOS/COS, and Gold Car all mean the same thing - the pricing sheet should be revised to include the 3Mbps speed option and billed at a zero rate.

Port Only Cross Connect should be added to price sheet and zero rated.

Verizon commits to provide the best service possible. I look forward to continuing our business relationship and building an even stronger partnership with the State of West Virginia
