

As a result, Greenbrier Motor Company is the lowest responsible bidder, and received the award for this classification.

Mr. Tincher,

Regarding your bid solicitation for statewide contract MV14 for motor vehicles, I am renewing my request to withdraw several of the items for which I bid, and am providing supporting documentation as you pointed out in your letter of November 25, 2013, would be required.

Under Class 6B, for which I bid a Jeep Grand Cherokee, I failed to realize that unlike Classes 6 and 6A, the specifications called for a V8 engine rather than a V6 engine. I priced this vehicle using the V6 engine which costs considerably less than the V8, therefore, to provide the V8 at this cost would cause a considerable monetary loss to my company.

Supporting documentation for Class 6B includes the relevant page from my bid indicating the model and the price, the price confirmation page from Chrysler's ordering system which was used to determine the cost to obtain the Jeep (the difference in this cost and the bid price represents additional costs such as filling the gas tank with fuel, among others, and a markup for profit), the Proposal from Chrysler for the amount of the special bid allowance (two pages), a copy of the order guide for the Jeep Grand Cherokee Laredo WKJH74 which matches the price on the order confirmation and lists only one available engine on that particular model, which is a 3.6L V6 engine, and finally a copy of the order guide for a Limited model WKJP74, which would be required to supply a V8 engine. The additional cost of the V8 engine is \$2,399 and the additional cost to upgrade from the Laredo to the Limited is \$5,824 (\$36,212 – 30,388) totaling \$8,223 in additional cost from my calculations using the V6.

Under Class 14, for which I entered two bids, one for a Ford and one for a Ram, I would like to withdraw the Ram bid only. I somehow picked up the Ford price and entered it into the Ram bid page. This price is incorrect and would cause a loss to my company as well. Supporting documentation includes both the Ford and the Ram bid pages that I submitted (as you can see the price is the same), the priced order confirmation from Chrysler indicating the cost of the truck, and the Special Bid Proposal amount related to this truck. The cost of obtaining this truck from the manufacturer is \$497 higher than my bid price and that cost does not include the cost of my requirements to fill the gas tank with fuel, provide a state inspection sticker and temporary tag, deliver the vehicle to surplus property, or the interest cost of waiting for payment of the vehicle.

Under Classes 14C and 15C I would like to withdraw the Ford bid in the CNG/Bifuel category only. These specifications both require a V8 engine. I was not aware at the time of the bid that Ford does not make available a CNG/Bi-fuel prep kit compatible with the V8 engine that allows for conversion of this truck to use this fuel. It is only available in the V6 F15O. To convert this truck with the V8 engine could void the Ford warranty. I have enclosed as supporting documentation a copy of my bid pages for both of these Classes, and a communication from Ford Motor Company dated July 31, 2013 announcing to dealers the option that they were adding to the F-15O that would allow for the CNG/Bi-fuel upfit on the 3.7L V6 engine. No mention is made of an option for the V8 engine. I have also enclosed a copy of two pages from the Ford F15O order guide, the first of which indicates the 3.7L CNG prep kit addition, and the second which provides the order code for the prep kit along with restrictions related to using this option. No option appears on this page for a 5.0L V8 engine prep kit.

I trust that this will fully document the reasons for my request for withdrawal, however, I would be most happy to discuss the enclosed documents and/or provide additional documentation if you don't believe the enclosures provide the appropriate foundation for a decision which would remove these bids from MV14.

I look forward to hearing from you.
