

**DEALER AGREEMENT  
FOR TIRE RELATED SERVICES**

The State of West Virginia has entered into a contract with The Goodyear Tire & Rubber Company to provide tires and services to the State and political subdivisions. Specific independent Dealers will be authorized by The Goodyear Tire & Rubber Company to provide tires and tire related services related to purchasing the tires (mounting tires, rotating tires, etc.). ("Dealer(s)" herein includes The Goodyear Tire & Rubber Company authorized dealers)

This Dealer Agreement will identify the responsibilities of the Dealer for the services provided by the Dealer. Dealers will need to sign the Dealer Agreement before the Dealer will be authorized to provide services to the State of West Virginia. This Agreement will be effective on the last signature date below.

The Dealer agrees to the following:

**1. PROFESSIONAL SERVICES.**

Dealer warrants that all services shall be performed in a professional and workmanlike manner consistent with standard industry practice; and in accordance with any approved Statement of Work, if applicable. Dealer agrees to abide by all applicable laws, regulations, and industry standards when performing services for the State.

**2. INSURANCE REQUIREMENTS.**

The Dealer will agree to carry all insurance which may be required by federal and state laws, state and city ordinances, charters, regulations, and codes. The Dealer certifies that it has now and will continue to have in full force and effect the following certificates of insurance. Copies of the insurance certificates shall be provided to the State within ten (10) days upon request. All Insurance shall be issued by an insurance company authorized by the Insurance Department to transact business in the State of West Virginia. No policy shall expire, be canceled or materially changed to effect coverage available to the State without thirty (30) days written notice to the State.

a. **Liability insurance:** a certificate of insurance evidencing insurance coverage for general liability including contractual liability, written on a comprehensive form with coverage for personal injury and a limit of liability of at least \$1,000,000 for bodily injury, property damage and personal injury.

b. **Worker's compensation and employer's liability:** a certificate of insurance evidencing statutory coverage for worker's compensation coverage, injury and a limit of liability of \$1,000,000 for employer's liability, or a letter of certification from the industrial commission that the Dealer is an authorized self insurer.

c. **Garage liability including Garage Keepers Legal Liability:** a certificate evidencing coverage with a minimum limit of \$100,000 and to include loss of use of state operated vehicle(s).

**3. HOLD HARMLESS.**

The Dealer shall release, protect, indemnify and hold the State and its officers, agencies, employees, harmless from and against any damage, cost or liability, including reasonable attorney's fees for any or all injuries to persons, property or claims arising from acts or omissions of the Dealer, its employees or subcontractors or volunteers.

4. CONTRACT WITH THE GOODYEAR TIRE & RUBBER COMPANY


