AMENDMENT TO CONTRACT FOR CREDIT CARD AND CHARGE CARD SERVICES AS SET FORTH ON PURCHASE ORDER NO. AUD115000 DATED AUGUST 23, 2010

This Amendment ("Amendment") is made and entered into as of July 25, 2013 ("Amendment Date") by and between Citibank, N.A., a national banking association ("Citibank"), and the State of West Virginia Department of Administration, Purchasing Division ("State"). Capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Agreement (as defined below). Section and Addenda references in this Amendment are to sections of and addenda to the Agreement.

WHEREAS, the State and Citibank entered into that certain Contract for Credit Card and Charge Card Services as set forth on Purchase Order No. AUDI15000 dated August 23, 2010 (as amended, the "Agreement") pursuant to which Citibank has agreed to provide a commercial card program (the "Program"), and

WHEREAS, pursuant to the Agreement the State has the ability to offer purchasing card services that are made available to the State under the Program and for which the State is liable to local municipality governments, educational institutions, and other entities throughout the State (collectively, "State Liability Entities"), and

WHEREAS, the State desires to amend the Agreement, *inter alia*, in order to permit the participation of Non-State Liability Participating Entities (as defined below) in the Program, as specifically set forth below.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties hereto agree as follows:

From time to time, in addition to electing to have State Liability Entities participate in the Program, the State may inform Citibank that the State desires to have one or more of the following entities participate in the Program: such local municipality governments, educational institutions, and other entities throughout the State that the State (i) requests be permitted to participate in the Program, and (ii) informs the Bank that such governments. institutions, or other entities (but not the State) will be solely liable for amounts incurred in respect of their participation under the Program (each such entity or organization, a "Non-State Liability Participating Entity"). The State acknowledges that Non-State Liability Participating Entities shall be entitled to receive their own rebate in accordance with the terms of the Agreement, and that the State will not be entitled to any rebate in respect of amounts incurred by Non-State Liability Participating Entities under the Program. In order for any such Non-State Liability Participating Entity to qualify to participate in the Program, such entity and Citibank must each execute the form of participation agreement attached hereto as Addendum 1 (the "Participation Agreement"). Once such Participation Agreement is fully executed, the Non-State Liability Participating Entity that is a party thereto shall be deemed to qualify to participate in the Program. A Non-State Liability Participating Entity may not participate in the Program until a Participation Agreement with respect to such Non-State Liability Participating Entity is fully executed. Other than the State informing Citibank of its desire to have a Non-State Liability

Participating Entity participate in the Program as provided above, no further consent of the State is required in order for a Participation Agreement to be entered into with any of the aforementioned Non-State Liability Participating Entity, it being understood and agreed that the State hereby consents to each of such Non-State Liability Participating Entity(ies) entering into a Participation Agreement and participating in the Program. For the avoidance of doubt, other than with respect to Non-State Liability Participating Entities, the State shall be liable for all amounts incurred by all other local municipality government, educational institution, and/or other entity throughout the State which, as provided in the Agreement, the State seeks to have purchasing card services made available under the Program.

- 2. The "One Card Addendum A" to the Agreement is hereby deleted in its entirety and the "One Card Addendum A" attached hereto is inserted in lieu thereof.
- 3. Except as amended hereby, the Agreement is ratified and confirmed in all respects and all provisions of the Agreement shall remain in full force and effect according to the terms and conditions contained therein.

3. Late Payment Interest Rate

For the State: Per West Virginia Code.

For Non-State Liability Participating Entities: Basis for Variable Rate: Prime Rate pius 2% per annum. Adjustment frequency: Monthly. Prime Rate is the Clabank, N.A. "Prime Rate" published in The Wall Street Journal on the applicable date as such rate may change from time to time.

Pricing

The pricing term for this Agreement shall be effective for five (5) years from the date hereof or for the term of this Agreement, whichever time is shorter. Citibank will honor pricing for the State's option years, beyond the initial five (5) year contract term.

The State of West Virginia and Non-State Liability Participating Entities shall be sligible for rebates according to the rebate parameters set forth below. Pricing is inclusive of any financial support that may be provided by the Bankcard Associations.

Transactions associated with reduced large ticket interchange will receive 50 basis points rebate. The combined sales volume for the State, State Liability Participating Entities and all Mon-State Liability Participating Entities of regular and large ticket transactions will determine the sales volume ter for sales volume. Rebate payments will be remitted to the State of West Virginia or the applicable Non-State Liability Participating Entities quarterly. The sales volume at each rebate period will be annualized to determine the appropriate sales volume threshold for basis point calculation. At the end of each 12 month period, actual annual sales volume will be determined beginning with the first day of the 12 month period and the necessary adjustments will be made and included in the final quarter's payment. The method for calculating the payment performance is based on the monthly pay date for each month in the quarter. The annual sales volume will be calculated as purchases less returns, credits, cash advances and convenience checks. Rebates are not of all credit losses and, upon a Termination Event, not of the full cutstanding balance due from the Company under this Agreement and any other commercial card program between the Bank and Company or any of Company's Affiliates. The Bank reserves all rights of setoff under applicable law.

If cost of funds varies significantly, pricing is subject to change. For every twenty five (25) basis points increase in the Base Fed Funds sate, the Rebates outlined below will be reduced by two and one half (2.5) basis points. Base Fed Funds rate is that rate which is effective as of August 23, 2010

Early Payment Incentive: As set forth above as a note to the Rebate Schedule, for payments made as early as the third day after the billing statement date, Contractor shall add one (1) basis point for every day early (prior to day 25) that the State remits payment. For payments received from day 26 through day 35, Contractor shall decrease one (1) basis point for each day up through day 35. Sales volume associated with a payment received after day 35 will not qualify for rebates.
- 7. Signing incentive: Citibank will not be providing a Signing incentive.
- 8. Large Ticket Rebate: Citi is offering the State 50bps rebate on all large ticket items.

WHEREAS, Citibank, N.A. (formerly Citibank (South Dakota), N.A.), a national banking association ("Citibank"), and the State of West Virginia Department of Administration, Purchasing Division (the "State") entered into that certain Contract for Credit Card and Charge Card Services as set forth on Purchase Order No. AUD115000 dated August 23, 2010 (as amended from time to time, the "Agreement"), and pursuant thereto provided for the availability of the commercial card program (the "Program") to Non-State Liability Participating Entities (as defined in the Agreement); and,

WHEREAS, the Participating Entity desires to participate in the Program as a Non-State Liability Participating Entity, and Citibank and the State agree that the Participating Entity may participate in the Program as a Non-State Liability Participating Entity, subject to the terms of this Participation Agreement and the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties hereto agree as follows:

- 1. Participation in Program: By entering into this Participation Agreement with Citibank, the Participating Entity may participate in the Program under the terms and conditions set forth in the Agreement and in this Participation Agreement, and agrees to be bound by the terms and conditions contained in this Participation Agreement and in the Agreement. Capitalized terms used but not defined in this Participation Agreement shall have the respective meanings set forth in the Agreement. In the event of any conflict between the terms of this Participation Agreement and the terms of the Agreement, the terms of this Participation Agreement shall control.
- 2. Participation and Credit Review: Notwithstanding anything herein to the contrary, before Participating Entity may participate in the Program and before Citibank will extend any services or credit to Participating Entity, the Participating Entity must first submit to Citibank a completed Participating Entity Informational Form, in the form attached hereto as Exhibit A, and such other information as Citibank requires in connection with determining the creditworthiness of the Participating Entity. If Citibank determines that the Participating Entity is adequately creditworthy and the Participating Entity has a projected annual spend volume of at least \$5,000,000.00, then the Participating Entity will be able to participate in the Program and receive Services and credit from Citibank pursuant to the terms of this Participation Agreement as a Non-State Liability Participating Entity.

- 3. Billing and Payment Procedures: The terms of this Section 3 shall apply to all accounts established under the Program:
 - (a) The Participating Entity is liable for and shall pay in full by the due date set forth in this Participation Agreement, all charges, fees, and other costs incurred on the accounts in accordance with the terms of the Agreement and this Participation Agreement, including, without limitation, with respect to Cards and accounts in the name of the Participating Entity departments, divisions and individuals.
 - (b) For each statement period that there is account activity, Citibank will provide the Participating Entity with a statement for the account, which will indicate the outstanding balance, amount due and the payment due date. In addition, it will show an itemized list of current purchases, payments and credits, and, if applicable, any other charges or fees as provided for in this Participation Agreement and/or in the Agreement.
 - (c) Unless required by applicable law or otherwise agreed between the Participating Entity and Citibank, all account statements will be provided to the Participating Entity via an electronic method. If necessary to retrieve statements, the Participating Entity shall ensure that each Program Administrator or other authorized employee of the Participating Entity has secure encrypted access to Citibank's website to access and view electronic account statements.
 - (d) If the Participating Entity sends a payment that exceeds the amount due on an account, Citibank will reflect the amount of the excess as a credit against future charges on the account. The Participating Entity may request a refund of a credit balance.
 - (e) Citibank may accept late or partial payments (including, but not limited to, those marked as in settlement of a dispute or "payment in full" or with other restrictive endorsements), without losing any of its rights under this Participation Agreement. The Participating Entity is required to comply with all requirements established by Citibank regarding procedures for remitting payments to Citibank and required information to be included with payments. The Participating Entity acknowledges that a failure by the Participating Entity to comply with Citibank's procedures for remitting payments may result in late payment of amounts due, assessment of late charges, reduction in the spending limit of the subject account(s), and/or the closing or suspension of the subject account.
- 4. Rebates: The Participating Entity agrees to the methodology for rebate calculation and terms for rebate payment, as appropriate, as set forth in the Agreement.
- 5. Spending Limit: The initial aggregate spending limit for the Participating Entity under this Participation Agreement is set by Citibank. With respect to any sub-limits applicable to individual accounts, the Participating Entity may advise Citibank of the Participating Entity's desired sub-limit allocation for such accounts. Citibank may lower or raise the aggregate spending limit for the Program and any account sub-limit in Citibank's sole discretion; provided

that, in the event of a decrease in the aggregate spending limit for the Program, Citibank will inform the Participating Entity as soon as reasonably practicable of such decrease.

- 6. Contract Term: Except as provided herein, this Participation Agreement shall remain in full force and effect from the Effective Date and shall continue thereafter until terminated by either party in accordance with the terms of the Agreement and/or this Participation Agreement, or otherwise upon ninety (90) days' prior written notice to the other party. Upon the expiration or termination of this Participation Agreement for any reason, all accounts shall be deemed canceled effective upon termination and all outstanding amounts owed in connection with the accounts shall be deemed immediately due and payable. The term of this Participation Agreement may extend beyond the term of the Agreement, it being understood that the terms of the Agreement shall nevertheless continue to apply to the Participating Entity's Program, to the extent applicable, as provided in this Participation Agreement.
- 7. Agreement Modification: Participating Entity acknowledges and agrees that the terms of the Agreement may be modified by Citibank and the State from time to time. In such event, Citibank will inform the Participating Entity of such modifications, and the Participating Entity shall be deemed to have agreed to such new terms and conditions if the Participating Entity continues to use the Program and does not provide a written notice of termination of this Agreement within thirty (30) days of Citibank informing the Participating Entity of such modification.
- 8. Notices: All notices from Citibank to the Participating Entity shall be sent by Citibank to the Participating Entity at the contact information designated below, unless another address is designated by the Participating Entity in writing. All notices from the Participating Entity to Citibank shall be sent by the Participating Entity to Citibank at the contact information set forth in the Agreement, unless another address is designated by Citibank in writing.
- 9. Severability. The invalidity or unenforceability of any one or more provisions, sentences, clauses, sections or paragraphs in this Participation Agreement shall not affect the validity or enforceability of the remaining portions of this Participation Agreement or any part hereof. If any provision (or portion thereof) of this Participation Agreement is found to be invalid or unenforceable, such provision (or portion thereof) shall be amended to be construed as nearly as possible to reflect the original intent of the parties, and the remaining portions of this Participation Agreement shall remain in full force and effect in accordance with their terms.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

Under penalty of law for false swearing (West Virginia Code §61-5-3), it is hereby certified that the vendor affirms and acknowledges the information in this affidavit and is in compliance with the requirements as stated.




