Re: SANPAP17 - Award Protest

Mr. Gurzenda,

I received your letter dated August 31, 2017, in which your firm is protesting the award of the above identified contract to Liberty Distributors ("Liberty"). In that protest, you raise six specific objections to items contained in the specifications. Those objections were forwarded to Liberty Distributors for further information. The objections and decisions are shown below. A copy of the response from Liberty distributors is enclosed herewith.

Objection 1: Item #6- Liberty Distributors quoted Kimberly Clark #07805- Bid references minimum of 0.0062 lbs./sq. ft. (3.1.1.3.6.3) The Kimberly Clark item submitted by Liberty Distributors is .0059 lbs./sq. ft. Liberty Distributors is non-compliant with the minimum requirement.

Purchasing Division Decision: Line item #6 was stricken from the contract award to Liberty Distributers and was not included in the award evaluation. After removing this line item, Liberty Distributors was still the lowest bidder.

Objection 2: Item #8- Liberty Distributors quoted Georgia Pacific dispensers but only quoted Kimberly Clark product. This dispenser will not work for the quoted tissue.

Purchasing Division Decision: Liberty Distributors asserts that the dispenser quoted is a universal dispenser and will work with the product quoted. The Purchasing Division accepts the explanation provided by Liberty Distributors.

Objection 3: Item #9- Liberty Distributors quoted Georgia Pacific dispensers but only quoted Kimberly Clark product. This dispenser will not work for the quoted tissue.

Purchasing Division Decision: Liberty Distributors asserts that the dispenser quoted is a universal dispenser and will work with the product quoted. The Purchasing Division accepts the explanation provided by Liberty Distributors.

Objection 4: Item #10- Liberty Distributors quoted Kimberly Clark # 09507. The bid requires a single roll dispenser (3.1.2.4.3.1)-The Kimberly Clark is a double roll dispenser. Liberty Distributors is non-compliant with the minimum requirement.

Purchasing Division Decision: This item will be eliminated from the contract award and the award evaluation. After removing this item, Liberty Distributors still had the lowest bid.

Objection 5: Item #29- Liberty Distributors quoted Kimberly Clark # 09217. The bid requires a metal dispenser (3.1.6.4.1.1). The Kimberly Clark is made of plastic. Liberty Distributors is non-compliant with the minimum requirement.

Purchasing Division Decision: This item will be eliminated from the contract award and the award evaluation. After removing this item, Liberty Distributors still had the lowest bid.

Objection 6: Item #37- Liberty Distributors quoted KC #05325 is not a valid Kimberly Clark product code. Liberty Distributors is non-compliant as this is not a valid code and not available for purchase.

Purchasing Division Decision: Liberty Distributors claims to have made a clerical error when inserting the product number, but inserted the appropriate support documentation. The Purchasing Division reviewed the file and found that Liberty Distributors did in fact submit the correct product sheet. The clerical error in Liberty Distributors' bid is waived as a minor irregularity pursuant to the authority vested in my office by W. Va. CSR § 148-1-4.6.

Accordingly, the contract award to Liberty Distributors will be modified to remove line items #10 and #29. The relief you have requested in the form of cancelation of the contract award to Liberty Distributors and re-award to Veritiv is hereby denied.

Dear Mr. Sheets,

The following is Liberty Distributor's response to the protest letter from Veritiv for the above named contract:

Item #6: The product quoted is the current product that the State of WV has been using for the past 10 years. We feel that this was a formulation error. We are sure that the State of WV would not disqualify a product based on a difference of three ten thousandths of a pound per square foot.

Items #8 and #9: The dispensers quoted are UNIVERSAL dispensers and will fit the products quoted.

Item #10: Line item 5 is a 12" Jumbo Toilet Tissue. Since there was no request for a 12" Jumbo Dispenser, Liberty quoted a dispenser that will fit a 12" roll of toilet tissue. In addition, the dispenser quoted has a "stub roll" feature that allows a partially used roll to be moved to the front while putting a new 12" roll into place. This is a time saver for maintenance. The dispenser will also serve to be used for 2, 9" Jumbo Junior toilet tissue rolls, should the customer choose to do so. The descriptive literature was included with the bid.

Item #29: The product quoted is the same as on the current bid. It is made of ABS plastic (same as football helmets for durability). Liberty has merely changed brands from the current bid in place. Metal is not a standard in the industry and we feel that it was specified in error. There has been no usage on this item this year.

Item #37: This was merely a typo when entering the item number. The correct Kimberly Clark code is 05925. The correct product sheet was submitted.

Subject: Protest Contract Award to Liberty Distributors – Contract # SANPAP 17

Veritiv/xpedx is protesting the contract award to Liberty Distributors for the Sanitary Paper Supplies contract issued on August 31, 2017 by the State of West Virginia purchasing division. The contract has an effective start date of December 1, 2017. Contract # SANPAP 17.

Veritiv/xpedx, via a fax on August 31st, was notified that Veritiv/xpedx was not the successful bidder. In addition, I spoke and confirmed with Ms. Brittany Ingraham and Mr. Guy Nisbet on Thursday August 31st via telephone that the contract was awarded to Liberty Distributors but was not yet posted to the state's purchasing website. In review of the bid tabulations, the low cost bidder was Liberty Distributors. This protest has merit as the products that were submitted by Liberty Distributors were not to the specifications outlined and referenced in solicitation SWC 1800000001.

Specifically, Liberty Distributors submitted the following:

Item #6- Liberty Distributors quoted Kimberly Clark #07805- Bid references minimum of 0.0062 lbs/sq ft (3.1.1.3.6.3) The Kimberly Clark item submitted by Liberty Distributors is .0059 lbs/sq ft. Liberty Distributors is non-compliant with the minimum requirement.

Item #8- Liberty Distributors quoted Georgia Pacific dispensers but only quoted Kimberly Clark product. This dispenser will not work for the quoted tissue.

Item #9- Liberty Distributors quoted Georgia Pacific dispensers but only quoted Kimberly Clark product. This dispenser will not work for the quoted tissue.

Item #10- Liberty Distributors quoted Kimberly Clark # 09507. The bid requires a single roll dispenser (3.1.2.4.3.1)-The Kimberly Clark is a double roll dispenser. Liberty Distributors is non-compliant with the minimum requirement.

Item #29- Liberty Distributors quoted Kimberly Clark # 09217. The bid requires a metal dispenser (3.1.6.4.1.1). The Kimberly Clark is made of plastic. Liberty Distributors is non-compliant with the minimum requirement.

Item #37- Liberty Distributors quoted KC #05325 is not a valid Kimberly Clark product code. Liberty Distributors is non-compliant as this is not a valid code and not available for purchase.

Veritiv/xpedx requests that the State of West Virginia cancel the contract award to Liberty Distributors and awards to Veritiv as we were the next lowest responsive and responsible bidder.
