ASSIGNMENT AND ASSUMPTION AGREEMENT

FOR CLIENT: State of West Virginia (“Client”)

This Assignment and Assumption Agreement is executed and delivered this 8th day of October, 2021 (the “Effective Date”), by and between G4S Secure Solutions (USA) Inc., a Florida corporation (“G4S”), and Universal Protection Service, LP, a California limited partnership, for itself and on behalf of its wholly-owned subsidiary Universal Protection Service, LLC, a Delaware limited liability company, both d/b/a Allied Universal Security Services, which may be performing work in certain jurisdictions and localities (collectively “Allied Universal”), successor to G4S.

RECITALS

WHEREAS, G4S previously entered into an agreement with Client (the “Security Service Agreement”) for the provision of security services and related services at Client’s facilities (each a “Property” and, collectively, the “Properties”);

WHEREAS, G4S desires to assign and Allied Universal desire to receive the Service Agreement pursuant to the terms and conditions set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein, and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, G4S and Allied Universal do hereby agree as follows:

1. Assignment and Assumption. G4S hereby assigns, sells, transfers and sets over to Allied Universal all of G4S’ right, title, benefits, privileges and interest in the Security Service Agreement (collectively, the “Assets”), and all of G4S’ obligations and liabilities in connection to such Assets (collectively, the “Assignment”). Allied Universal hereby accepts the Assignment and assumes and agrees to observe and perform all of the duties, obligations, terms, provisions and covenants, and to pay when due and discharge all of the liabilities of G4S to be observed, performed, paid or discharged from and after the Effective Date, in connection to the Assets Allied Universal assumes by the operation of this Assignment.

2. Successors and Assigns. Except as otherwise provided in this Agreement, the rights and obligations of G4S and Allied Universal hereunder will be binding upon and inure to the benefit of their respective successors, assigns, heirs, executors, administrators and representatives.


3. Facsimile or Scanned Signature. This Agreement may be executed and delivered in counterpart signature pages executed and delivered via facsimile transmission or via email with scan or email attachment, and any such counterpart executed and delivered via facsimile transmission or via email with scan or email attachment will be deemed an original for all intents and purposes. All signatures will be deemed to be delivered simultaneously.

On **April 5, 2021**, we announced that Allied Universal had acquired G4S. Over the last few months, the combined leadership of both legacy companies has been diligently working to integrate the best of both world-class organizations. We are pleased to announce that your security program, together with all legacy G4S services, will be integrated into Allied Universal operations on **October 8, 2021**.

As the President of Allied Universal's Southeast region, I want to thank you for your trust and confidence in Allied Universal. This integration enables us to combine both legacy companies' resources to provide you—our valued client—with more experience, more expertise, and more access to state-of-the-art security solutions.

Please be assured that you will experience no disruption to your current service during or after the transition. However, there will be some minor changes to current processes as a result of the integration, all beginning on **October 8, 2021**:

- Security Professionals will begin wearing uniforms bearing the Allied Universal brand (unless the current uniform is not branded – in that case, there will be no change to Security Professional uniforms).
- Invoices will originate from the Allied Universal billing system. **(Sample invoice attached.)**
 - You will receive future invoices from an @aus.com email address. **(Please update spam filters accordingly.)**
- For your convenience, an updated **Form W-9** is attached.
- Depictions of the Allied Universal billing cycles are enclosed.
- Client Payments:
 - Lockbox addresses will remain the same, except checks should now be made payable and addressed to “Allied Universal.” Please refer to the enclosed “Lockbox Addresses” section.
 - For **ACH** or **Wire** payments, you can find bank instructions in attached document. The account number will remain the same as they were for G4S, but the remittance address will change to Remittance@aus.com.
- Insurance coverage across all policies is still in place and not impacted at this time. Updated certificates of insurance documenting go-forward coverage will be delivered to existing certificate holders prior to 10/8/2021. If you do not receive a COI or if you require an additional copy, you can reach out to your Allied Universal point of contact.
- Legacy G4S services such as SecureTrax and the Custom Protection Officer (CPO) program, if applicable to your account, will continue to exist in the same form with only minor visual changes from re-branding.
