RE: Emergency Hauling of Leachate from the Kingwood Landfill to City of Kingwood Wastewater Treatment Plant

Dear Mr. Sheets,

The WVDEP Landfill Closure Assistance Program is requesting approval of emergency leachate hauling from the Kingwood Landfill to the City of Kingwood Wastewater Treatment Plant for 60 days. The estimated cost for this emergency approval is \$250,000.00.

The leachate at the Kingwood Landfill is stored in an approximately 171,000-gallon total capacity storage tank, which includes a 74,000-gallon primary tank and a 97,000-gallon secondary tank. Currently, both tanks (primary and secondary) are full and holding the approximately 171,000-gallons of leachate.

On February 17, 2021, the LCAP Project Manager, DLR Deputy Director and the DLR Engineer Chief were onsite to inspect the tanks. During the inspection, it was discovered that due to the extremely cold weather, the leachate is capped off with ice which could damage the tanks. The cost to install the current leachate storage tank was \$300,500.00, the cost to replace a damaged leachate storage tank could potentially be greater than the original price. Additionally, the ice could cause the leachate to back up into the landfill which would cause overflowing of the leachate tank once the lines thaw. The freeze and thaw effect could also cause the landfill cap to experience blowouts which could also be costly to repair.

Preston County experiences higher than normal rainfall and snowfall which has resulted in the Kingwood Landfill producing more leachate than originally anticipated. Emergency hauling would prevent leachate from flowing into an unnamed tributary of Greens Run. Leachate flowing into Greens Run could have a disastrous impact on residents and wildlife that are located adjacent to the Landfill.
