Re: Emergency Request for Direct Care Staffing

Dear Mr. Sheets:

The WV Veteran's Nursing Facility is requesting approval of Two (2) emergency contract for Direct Care Staffing for a term of six (6) months. CMA's VNF309413A-F ended 4/30/21 and CMA's VNF21\*17A-C were issued. CMA VNF21\*17A-C was limited to three (3) vendors and 2 of them are new to our facility. The 2 new vendors have not yet been able to provide any staff for our needs and the 1 that is cannot supply all the needs. Some vendors have indicated they can provide RN's and LPN's on an as-needed basis, but not HSW's. Therefore, we'd like to issue 2 emergency contracts with HSW separate from RN and LPN.

Costs for Direct Care Staffing for the 6 months from 11/01/20 - 4/30/21 were \$1,289,632.90 and we anticipate the costs for this emergency contract to be about the same if we use it for the full 6 months. Our estimated needs for staffing are 212 hours per week for RN's; 612 hours per work for LPN's; and 680 hours per week for CNA/HSW's. These estimates are based on our current state staff, which is 1 RN, 12 LPN's and 25 HSW's at this time. The needs vary based on how many state staff we have, as well as vacations, sick leave, etc.

As a nursing home, we must have a certain number of nursing staff per resident working at any given time. Without such, we run the risk of life or health and safety issues of not providing the appropriate care to our residents. Direct Care Staffing services are vital to the health and well-being of our residents, as well as the continuity, purpose, and mission of our facility.
