RE: Emergency Repair of Kingwood Landfill Aboveground Leachate Storage Tank

Dear Mr. Sheets,

The West Virginia Department of Environmental Protection (WVDEP), Division of Land Restoration (DLR), Landfill Closure Assistance Program (LCAP) is requesting an emergency purchase order for the repair of the aboveground leachate storage tank at the Kingwood Landfill. The estimated cost of this emergency is approval is \$30,000.00.

The leachate tank at the Kingwood Landfill is a bolted glass-fused-to-steel panel 74,000-gallon glass-coated, bolted steel primary tank with a 97,000-gallon glass-coated, bolted steel tank and foundation secondary tank. At some point this winter (exact date unknown) the inside primary tank began to leak into the secondary tank outside secondary storage tank must have had at least 4 inches more leachate than the inside primary storage tank. This caused the primary tank to “float”, which means the primary came off its foundation. If the leachate level in the secondary tank is greater than the leachate level in the inner primary storage tank, this can put stress on the inner primary tank until the glass panels begin to crack. Additionally, several areas of the splice plates located around the primary tank are bowed and show damage where the tank has tried to "weaken".

The requested emergency repair will primarily consist of dewatering the leachate tank; investigating the inside floor and walls of the primary tanks to see if the concrete base needs is cracked and needs repaired; installing a sealant (i.e., Manus-Bond 75-AM Industrial Grade, or equivalent) to patch areas where the primary tank floated; applying liquid urethane concrete bridging (i.e., CIM 1000 or equivalent) around the interior perimeter to seal any additional cracks and gaps; and, installing a sump pump and associated piping to go up and over the tank

sidewall and back into the primary tank to prevent the secondary tank from holding more leachate than the primary tank.

For the reasons listed above, LCAP is requesting approval of this emergency contract for the repair of the aboveground leachate storage tank at the Kingwood Landfill.
