## Re: Emergency Purchase Tableau Software Licenses

The Office of Management Information Services (OMIS) on behalf of the Bureau for Public Health (BPH) is seeking approval to award an emergency purchase for sixty (60) Tableau software licenses for a twelve-month period.

A solicitation was released on January 4, 2023 (CRFQ MIS2300000002) for the following:

#### PRODUCTS REQUIRED FOR COMPLETE TABLEAU SOFTWARE PLATFORM

Tableau 8 Core Base (Server) MFG Part 200001798; Embedded Analytics 8 Core Base (Server) MFG Part 200001800; Tableau JumpStart MCF Part 200001994; Tableau Creator (Server) MFG Part # 200001773; Tableau Training eLearning (Creator) MFG Part # 200001553

The contract was awarded to the lowest responsive bidder, Vcloud Tech, Inc. (CMA MIS230000002) with an effective start date of March 1, 2023. The terms and conditions of the contract were for one year of service with three optional one-year renewal periods.

When the vendor submitted an invoice with service periods that did not match the contract, we investigated further and determined the vendor had provided licenses by co-terming them with an existing Tableau account BPH had.

Co-terming to another account or a shortened service period was not noted or mentioned during the solicitation process or on the vendor's bid. The co-terming period on the invoice does not provide the proper contract duration as listed in the terms and conditions of the contract.

OMIS and BPH have tried to resolve this issue with VCloud and unfortunately, we cannot continue with the existing service and contract. The agency is using grant funds for this purchase and these licenses have already been assigned to users. The agency does not have adequate time to go through another solicitation process because the service expired on July 7, 2023.

The agency has been given a two-week extension by Tableau for the current licenses to remain active while we secure a new agreement.

We request your approval to proceed with an emergency purchase for a contract period of one year which will allow us time to issue a new solicitation for these licenses.

We estimate the cost will be \$345,000.00 for (60) sixty Tableau licenses for a (12) twelve-month period.
