AML received a complaint (2025-SOU-045-080) on 4/15/25 concerning a draining mine portal and associated drainage problems at 101 Lexijo Drive at Yuma Camp in Logan County. The AML Investigation found a partially collapsed, draining, mine portal adjacent to the residence. The portal discharge was estimated to be approximately 60 gallons per minute. Multiple seeps were found around the home, both outside and inside the garage. The elevations of the seeps were above the mine portal discharge, indicating the potential of impounded water in the collapsed portal.

Although the mine discharge has been present for decades, the sudden appearance of the seeps are concerning. There is potential for impounded water in the mine to suddenly "blowout", causing extensive damage to the complainant's residence, as well as other structures in the flow path, while placing local residents in harm's way.

AML research determined the collapsed portal is in the Powellton Seam, last mined by the Monitor Coal & Coke Co., Yuma-Alma Mine No.3 in 1943.

AML recommends completion of an Emergency Project to mitigate the dangerous impoundment.

The project is expected to consist of exploratory drilling to determine the extent of the mine pool, mine dewatering, wet seal construction and ancillary drainage structures. Construction costs are estimated to be \$175,000.

Promoting a healthy environment.

Professional services will be utilized to design the reclamation. E.L. Robinson Engineering has been selected to perform the engineering design for the project. Professional services are not expected to exceed \$75,000.
