The WV Enterprise Resource Planning Board is writing to request approval for an emergency purchase of Actian Data Connect Integration Manager software. This software is critical to the State's payment systems. Without this software in place, vendors and employees will be unable to receive payment from the State.

This software was placed out for bid and was awarded to Insight Public Sector, Inc. with a contract start date of August 16, 2024. The wvOASIS identifier for this contract is CCT ERP2500000001. Our current licenses for this software are managed by CGI Technologies and Solutions and are set to expire on August 30, 2024.

Insight Public Sector has informed us that they are unable to procure the licenses from Actian, because of an agreement dispute. Insight has relinquished this contract and allowed us to procure the licenses direct from Actian.

We are currently in contact with Actian to purchase these licenses to avoid any service interruption. The total cost of the existing contract is \$187,060.32, and Actian has agreed to honor this pricing. These licenses will be purchased for one annual period commencing on the date of this purchase and will replace CCT ERP2500000001. We are requesting permission to make this purchase by foregoing the formal bid process, as time is of the essence in receiving these software licenses.
