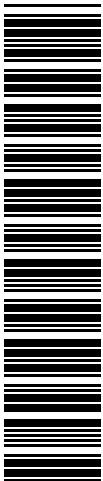

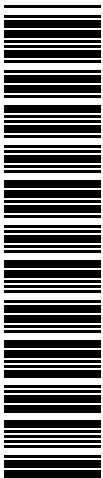

If you are exempt from the fee, you are still required to register. The Business Registration Fee cannot be pro-rated. Continuing to operate a business without obtaining a registration certificate and paying the tax is a crime and may result in fines and/or imprisonment, W. Va. Code § 11-9.
