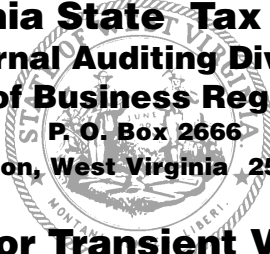

-  This application must be submitted with WV/Bus-App (Application For Business Certificate) and surety bond or other equivalent security such as a certified check or cash in the amount of \$500 or an irrevocable letter of credit.
-  Failure to display a valid Business License when making sales in West Virginia will subject the transient vendor's tangible personal property (and the automobile, truck or other means of transportation used to carry said property) to confiscation by the West Virginia State Tax Department.
