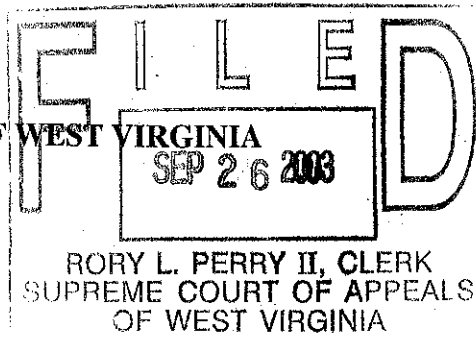


**NOTICE OF SUBSTITUTION OF COUNSEL FOR


