US Supreme Court denies WV Asbestos trial stay

The US Supreme Court yesterday issued an order refusing the stay requested late last week by Mobil and Owens-Corning. The stay would have halted asbestos mass litigation trial proceedings currently underway in the Circuit Court of Kanawha County.
