NOW THEREFORE, the Panel ORDERS that all Counsel shall file and serve a completed Notice of Appearance form on or before **November 6, 2008**.



All Counsel are further ORDERED to file and serve a Verification form, a copy of which is attached, stating that Counsel has provided the Court with a completed Fact Sheet for each party represented by Counsel on or before **December 8, 2008**.

The Clerk is ORDERED to forward a copy of this Order to all Counsel of record and all self-represented parties.
