Re: Deighton 2022 Software Pricing for WVDOH

To whom it may concern,

Deighton is pleased to present the West Virginia Division of Highways (WVDOH) with our product list and pricing which is current as of the date of this letter.

The contract term for this offer is December 1, 2022, to November 30, 2027 (i.e., a 5-year offering). This pricing supersedes any other previous pricing provided by Deighton.

The pricing is broken into two sections:

- Core Platform for our products based on 20 named licenses (items C1 to C4)
- Block pricing and associated discounts for additional licenses over and above the Core Platform (items A1 to A28)
 - The block size in terms of number of licenses is indicated as a header above each block

The following columns are shown in the pricing tables:

- ITEM – This is the item number for the product
- QTY – This is the number of units in the block for that item (i.e., the block size)
- UNIT – This is the unit as either EA or ANN
 - EA means the item is invoiced as a **one-time charge** at the time of purchase
 - ANN means the item is invoiced **annually** on November 1 of each year (for coverage period from Dec 1 to Nov 30 of each year)
 - For items purchased during the year, the item will be invoiced on the 1st of the following month of purchase and pro-rated to Dec 1 of each year, for example:
 - The Invoice Price on Sept 1 for an item purchased sometime in August would be:
 - Unit Price * 4/12 {since it is 4 months from Aug to Dec 1}
 - Then on Dec 1, the Invoice Price for that item would be the full annual amount
- DESCRIPTION – Item description
- BLOCK DISCOUNT – Any block discount for the block based on quantity purchased
- UNIT PRICE – The total Unit Price of the block
 - If a partial block is purchased, the following formula is used:
 - Unit Price / Qty * Number of Units
 - Example for annual amount if 75 units of OM is purchased:
 - C1 + A3 + (A7/50*25)

dTIMS BA provides the tools to create, manage, and analyze asset inventory and perform Life Cycle Cost Analysis (LCCA) of the WVDOH assets. Once the inventory is populated and configured, dTIMS OM will utilize that inventory for Operations and Maintenance users. Therefore, only Assets Stewards will



require a dTIMS BA license while still allowing dTIMS OM users to interact with the asset inventory through verified workflows configured during implementation. No LCCA can be performed with just an OM license.

West Virginia Code §5A-6-4(a)(3) permits the Chief Technology Officer to “evaluate the economic justification, system design and suitability of information equipment and related services, and review and make recommendations on the purchase, lease or acquisition of information equipment and contracts for related services by the state spending units.”

West Virginia Code §5A-6-4c requires that the Chief Technology Officer review and approve “a major information technology project.”

West Virginia Code §5A-6-5 requires that “any state spending unit that pursues an information technology purchase that does not meet the definition of a ‘major technology project’ and that is required to submit a request for proposal to the State Purchasing Division prior to purchasing goods or services shall obtain the approval of the Chief Technology Officer, in writing, of any proposed purchase of goods or services related to its information technology and telecommunication systems.

After conducting a review of your request for CMA DOT23*25 Renewal with Remaining three (3) Optional Years, the Office of Technology has determined:

X That your request is approved.

That your request is not subject to the review and approval provisions contained in Chapter 5A, Article 6 of the Code, therefore, it does not need approval by the Office of Technology.
