Emergency Purchase Request Timeline of Events – Actian DataConnect Software

Friday Aug. 16, 2024

- Insight Public Sector reached out by phone to notify us that there was an issue with their agreement with Actian. Their agreement was with the parent company HCL, and they needed to establish a relationship directly with Actian to procure the licenses as a reseller.
- Contract start date was today and licenses were supposed to be provided by EOB.

Monday Aug. 19, 2024

- Followed up with Insight to ensure they were going to reach an agreement with Actian and be able to provide the licenses withing the necessary timeframe.

Tuesday Aug. 20, 2024

- Emergency purchase authority was requested from the WV Purchasing Division to ensure timely approvals while Insight continued to work out an agreement with Actian.

Wednesday Aug. 21, 2024

- Insight Public Sector informed us that negotiations and documents were working towards completion and should be completed by the end of the day.

Thursday Aug. 22, 2024

- Insight Public Sector informed us that an agreement was not going to be made within our timeframe and to proceed with an alternative method of procurement.
- It was agreed that since SHI Int'l Corp. had an existing agreement with Actian and the State has worked previously with SHI that we would procure the licenses through them versus directly with Actian.

Friday Aug. 23, 2024

- Actian and SHI began exchanging quotes for these licenses and working towards establishing a purchase order.

Monday Aug. 26, 2024

- SHI provides the WV ERP Board with a quote and the WV ERP Board provides SHI with the State's General Terms and Conditions.
- SHI contract team begins review of T&C's.

- Evan Pauley contacted the WV Purchasing buyer, Larry McDonnell, to request approval to complete the order without the T&C's completed. Mr. McDonnell informed Mr. Pauley to provide the WV-96 to the vendor in lieu of the full T&C's, and as a last resort to "take care of the emergency" and procure the licenses prior to receipt of the T&C's or the WV-96.

Tuesday Aug. 27, 2024

- Continued discussion around the WV-96 and other T's and C's

Wednesday Aug. 28, 2024

- Continued discussion with legal from all interested parties regarding T's and C's and WV-96.
- Insight Public Sector provides official confirmation of their cancellation of the previous agreement that led to this emergency scenario.

Thursday Aug. 29, 2024

- With licenses set to expire on Aug. 30, 2024, the decision was made to continue deliberations on the T's and C's and WV-96 after the award of the contract. This software is vital to the State's operations.
- ACT ERP2500000001 was awarded to SHI Int'l Corp with a contract value of \$187,100 for one year of licensing.
