EIN Number Clarification

Dear Sir or Madam,

We are writing to clarify a question which arose regarding the Form W-9 we recently provided and which EIN should be used for payments to us.

The EIN listed in Part I of the W-9 is the EIN of our US parent company, Brenntag North America LC. This is required by the IRS when filling out W-9 forms for entities classified as “disregarded entities” for U.S. federal income tax purposes. Under those rules, the W-9 must reflect the parent entity’s information, even where business is conducted through a subsidiary.


Importantly, this does not change how you should do business with us, nor does it require you to use a different EIN from the one you historically used. Brenntag Mid-South remains a distinct legal entity under applicable state law, and it is the entity with which you contract and to which payments should be made. Accordingly:

- You should continue to use Brenntag Mid-South’s name and EIN (**61-0504545**) for payment, invoicing, and accounts payable purposes, exactly as you have done previously.
- The inclusion of the parent EIN on the W-9 is solely a federal tax reporting requirement and does not indicate that the Brenntag Mid-South EIN is no longer valid or should no longer be used for payment.
- In short, the W-9 format reflects IRS rules and does not alter our legal or commercial relationship, nor your payment instructions. The EIN you have used in the past for Brenntag Mid-South remains the correct EIN to use going forward.



The above-referenced change order is late in getting processed due to the Vendor changing their name on invoices beginning January 1, 2026. The Auditor's Office started rejecting the invoices due to the name inconsistency. DLR Procurement was made aware of the name change in December 2025, but the Vendor had to do the name change with Vendor Registration before a Change Order could be completed. The change did not occur in WVOasis until January 31, 2026 and DLR Procurement started the change order on February 18, 2026. Due to delay in getting the name change corrected in WVOasis, it was not submitted until March 3, 2026 to DEP Procurement.
