Amendment No. 3 to Master Agreement PO-10700-00050035

This is Amendment No. 3 ("Amendment") to Master Agreement PO-10700-00050035, dated July 1, 2025, as amended from time to time ("Master Agreement") between the State of Oregon, acting by and through its Department of Administrative Services, State Procurement Services ("DAS SPS") as the lead state, on behalf of the member states of NASPO ValuePoint Cooperative Purchasing Program and other Participating Entities and EAN Services, LLC for itself and as an agent for rental entities (individually and collectively referred to as "Contractor"). This Amendment is effective on the date signed by all parties and upon receipt of all approvals necessary for signing ("Amendment Effective Date").

AMENDMENT

The Master Agreement is amended as follows:

- 1. Exhibit 4.1 of the Contract is replaced with Revised Exhibit 4.1, in the form attached to this Amendment as Attachment 1, effective on the Amendment Effective Date.

This is Amendment No. 4 (“Amendment”) to Master Agreement PO-10700-00050035, dated July 1, 2025, as amended from time to time (“Master Agreement”) between the State of Oregon, acting by and through its Department of Administrative Services, State Procurement Services (“DAS SPS”) as the lead state, on behalf of the member states of NASPO ValuePoint Cooperative Purchasing Program and other Participating Entities and EAN Services, LLC for itself and as an agent for rental entities (individually and collectively referred to as “Contractor”). This Amendment is effective on the date signed by all parties and upon receipt of all approvals necessary for signing (“Amendment Effective Date”).

AMENDMENT

The Master Agreement is amended as follows:

1. Section 3 Term of the Master Agreement is amended to read as follows (new language is indicated by **underlining and bold** and deleted language is indicated by ~~strikethrough~~):

3. Term of the Master Agreement

This Master Agreement is effective on the date it has been signed by the parties and has been approved as required by applicable law (“Effective Date”). The initial term of this Master Agreement ends August 1, 2026 (“Initial Term”). **The amended expiration date of this Master is July 31, 2030.** This Master Agreement may be extended beyond the Initial Term for additional terms, at the Lead State’s discretion and by mutual agreement of the Lead State and Contractor and upon review of requirements of Participating Entities, current market conditions, and Contractor performance. The Initial Term and any additional terms are the “Term”. The Term of the Master Agreement, including the Initial Term and all renewal terms will not extend beyond July 31, 2030
